Job Description: Account manager

As account manager, the successful candidate will work as part of our account handling team, across a number of clients. Responsibilities and duties

- For some accounts, you will have primary day-to-day responsibility. For other accounts, you will work in a supporting role alongside a senior account manager/account director. The job will involve advising clients, interpreting clients' requirements and suggesting new ideas around all aspects of marketing, both online and offline.
- Evolving and implementing overall marketing strategies, as well as developing and progressing tactical activity. The ability to up-sell additional services.
- Attending client meetings. This will involve directing the progress of the meeting, preparation in advance of meetings and processing afterwards, including creating and circulating the agenda, producing accurate contact reports and taking responsibility for ensuring actions resulting from meetings happen as agreed.
